Board Members Present: Clerk Denise Livermore, Treasurer Jane Chaffee, Trustee Oplinger, Trustee Lawrence

Clerk Livermore called the meeting to order at 7:00pm

Treasurer Chaffee moved to appoint Trustee Oplinger chair, Trustee Lawrence supported, motion carried

Trustee Lawrence moved to approve the agenda, with the addition of Mary's Dream Charitable Gaming License and Weidman Days Fireworks permit as Items 7A and 7B, Treasurer Chaffee supported, motion carried.

Treasurer Chaffee moved to approve the minutes of 4/20/2015, Trustee Lawrence supported, motion carried.

Treasurer's Report as presented: GF \$264,810.11 / LIB \$172,089.04/ FIRE \$239,076.31/ LK HILLS \$38,875.73

Trustee Lawrence moved to approve Payment of the Bills, Treasurer Chaffee supported, motion carried.

Public Comments: Richard Moreau addressed the board on trash piles, he has been told from the Health Dept a letter was sent and the Lk of the Hills Association has sent a letter. Sue Hartway also commented on the health dept and how much the zoning administrator had helped them.

Clerk Livermore moved to approve a resolution to allow Mary's Dream a non-profit organization to receive a Charitable Gaming License from the State, Trustee Lawrence supported, Roll call vote – Trustee Lawrence – yes, Trustee Oplinger – yes, Clerk Livermore – yes, Treasurer Chaffee – yes, Absent – Supervisor Thompson, motion carried.

Trustee Lawrence moved we approve the fireworks permit for fireworks during Weidman Days on July 11th, Treasurer Chaffee supported, motion carried.

Time Nieporte and Ray Johnson were present to provide information as needed and to explain the zoning complaint process.

Treasurer Chaffee moved to send the zoning complaint for 7734 N Airpark to the attorney, as the zoning administrator has followed all the steps he has available with no response, Trustee Lawrence supported, motion carried. (NOTE: the next day a foreclosure hearing date of June 10th - was in the newspaper. Due to this information the board decided to hold off sending to the attorney and the zoning dept will contact the mortgage company at this time and see if we can get them to clean up the property)

Trustee Lawrence moved to send the zoning complaint for 3117 Woodruff Rd to the attorney, as the zoning administrator has followed all the steps he has available without compliance, Clerk Livermore supported, motion carried.
