Meeting Minutes
March 15, 2021

Meeting held at the Sherman township Hall, 3550 N Rolland Rd, Weidman, MI 48894

Supervisor Johnson called the meeting to order at 7:00 pm

Board Members Present: Supervisor Johnson, Trustee Grey, Treasurer Clark, Trustee Simon and Clerk Livermore

Board Members Absent: none

Clerk Livermore moved to approve the agenda, Trustee Simon supported, motion carried.

Supervisor Johnson opened the Public Budget Hearing at 7:02pm – he reviewed the taxes to be levied and copies of the proposed budget were available for the public.

There were no public comments on the budget.

Supervisor Johnson closed the Budget Hearing and resumed the regular meeting at 7:04 pm

Trustee Grey moved to approve the minutes of the February 15, 2021 meeting w/ the correction of Supervisor Johnson made to them in the “called the meeting to order line” and the minutes of the Special Meeting February 22, 2021, Treasurer Clark supported, motion carried.

Treasurer’s Report: GF \$288,699.34, Fire \$342,179.51, Lake of Hills \$24,167.74 Library \$134,547.31, Tax Acct \$1392.60

Trustee Grey moved to approve payment of the bills and to authorize the Clerk & Treasurer to pay all other bills that should be paid in this fiscal year before the end of March, Trustee Simon supported, motion carried.

Public Comment – Shirley Thompson stated it was nice to be able to see where the clerk & treasurer balance on all accounts.

Clerk Livermore moved to amend the 20-21 budget by taking \$1000 from the park and adding it to the Board of Review, Trustee Grey supported, motion carried.

Trustee Simon moved to adopt the 21-22 budget as presented, Treasurer Clerk supported, motion carried.

Clerk Livermore moved to approve the Brine Contract with the Isabella County Road Commission with the Supervisor & Clerk as signatories, Trustee Grey supported, motion carried.

Supervisor Johnson moved to request a quote for the 2 miles of Denver from Rolland to Sherman for our gravel project this year, Treasurer Clark supported, motion carried.

Supervisor Johnson gave an update on Board of Review.

Discussion on Personal Property Tax situation and review of attorney opinion was held.

Supervisor Johnson moved to approve the Lion’s Club hosting a circus June 30, 2021 in the park, Trustee Grey supported, motion carried.

Discussion on use of COA portion of building was held.

Public Comment – none

Comments from other entities were heard.

Individual Board member comments were heard.

Supervisor report was heard – Resident complaint about Weidman Rd from Old State to School – Board agreed we need to get a legal opinion.

Treasurer Clark moved to adjourn, Supervisor Thompson supported, motion carried.
