Supervisor Johnson moved to adopt the 22-23 Fire Millage Budget, Trustee Grey supported, motion carried.

Clerk Livermore moved to adopt the 22-23 Lake of Hills Weed Ctrl Special Assessment budget, Supervisor Johnson supported, motion carried.

Trustee Grey moved to authorize the Clerk to file and sign the ARPA funds report, Treasurer Clark supported, motion carried.

Clerk Livermore moved to approve the brine contract with the ICRC and authorize the Supervisor and Clerk to sign the contract, Supervisor Johnson supported, motion carried.

Clerk Livermore moved to approve the gravel road contract to do the miles suggested by our driver, and to authorize the Clerk and Supervisor to sign the contract, Supervisor Johnson supported, motion carried

Reports from other township entities were heard.

Individual Board member comments were heard -Trustee Grey said the Treasurer needs a new printer – he has one he suggests from Amazon. He will get a couple price comparisons for review at next meeting.
